

#### **EUSOMA PRIVACY POLICY FOR MEETINGS AND WEBINARS**

EUSOMA - the European Society of Breast Cancer Specialists respects individuals' concerns about privacy. The entity responsible for the collection and processing of data under this policy is:

In accordance with EU Regulation 679/2016 this Privacy Policy describes the types of personal data we collect, how we use that data, and with whom we share it. Our Privacy Policy also describes the measures we take to protect your personal data, how to exercise your rights and how to contact us.

### Personal data we collect and how we use it

We collect personal data by using a specific event's form or through a webinar platform as ZOOM. By personal data we mean "any information relating to an identified or identifiable natural person" such as name, address, e-mail, telephone number, the name of your organisation etc. Please take also into consideration that some web events can be recorded. The personal data we process is either provided directly by you via a specific form or on a web platform. If you choose not to give some data, this may affect your participation to the event and the services that we can offer you.

## Registering for an EUSOMA - the European Society of Breast Cancer Specialists event

If you decide to register for one of our events we ask for personal data such as your name, e-mail address, telephone number, the name of your organisation etc. This data will mainly be used for verification reasons and for statistic purposes.

We may use this data, with your consent, to:

- Send you information about our events and initiatives and allow you to participate in our initiatives;
- Update you on news in the scientific field;

### Personal data we share

We do not sell, rent, trade or otherwise disclose personal data outside EU.

We may share your personal data with service providers we have retained to perform various services on our behalf and in relation to the purposes set forth in this Privacy Policy. These service providers are contractually required to act only on our instructions and to maintain an appropriate level of data protection and data security. Service providers are not authorised by us to use the data for their own purposes or to disclose the data to third parties except as necessary to perform services or functions for EUSOMA - the European Society of Breast Cancer Specialists or to comply with legal requirements. For example, service providers are not authorised by EUSOMA - the European Society of Breast Cancer Specialists to use the data for their own marketing purposes.

We may disclose data about you: (1) if we are required to do so by law or pursuant to Court order, or (2) in response to a legitimate request from law enforcement authorities. We also reserve the right to transfer any data we have about you in the event we sell or transfer all or a portion of our business or assets. Should such a sale or transfer occur, we will use reasonable efforts to try to require that the transferee uses



personal data you have provided through this site in a manner that is consistent with this Privacy Policy. If you do not want the transferee to further process your data in such case, you should contact the transferee.

## **Your rights and choices**

You have the right to receive information about the personal data stored about you and to access and possibly amend your personal data by using the contact information provided below in the "How to Contact Us" section. Following any data access request, we will accommodate your enquiry as required by applicable law.

If the data collected is incorrect, inaccurate or outdated, we will correct them within a reasonable period of time following your request for correction. You also have the right to object to the processing of personal data by EUSOMA - the European Society of Breast Cancer Specialists, at any time on compelling legitimate grounds, except when otherwise provided by applicable law.

If the data is processed with your consent, you may revoke this consent at any time by using the contact information provided below in "How to Contact Us". If you decide to revoke your consent, we will make your personal data anonymous in the database and any reference to you will be deleted with effect to the future.

### **Data transfers**

EUSOMA - the European Society of Breast Cancer Specialists mainly collects, processes and uses your personal data within the European Union. If we transfer your personal data outside of the European Union or if we use third party service providers located outside of the European Union, we take the necessary steps to ensure compliance with applicable data protection law, in particular the legal requirements on adequate protection for data transfers to countries outside of the European Union.

## **Records retention**

EUSOMA - the European Society of Breast Cancer Specialists only retains personal data for as long as needed to fulfil the purposes for which they were collected, unless otherwise provided by law. When the data is no longer necessary to meet the purposes for which it was collected, it is deleted, blocked or anonymised.

## **Security**

We maintain appropriate administrative, technical and physical safeguards to protect personal data against accidental or unlawful destruction, accidental loss, unauthorized alteration, unauthorized disclosure or access, misuse, and all other unlawful forms of processing of the personal data in our possession.
